## CORNISH METALS ANNOUNCES EXERCISE OF STOCK OPTIONS AND ISSUE OF EQUITY & PDMR DEALINGS

**Cornish Metals Inc.** (**TSX-V/AIM: CUSN**) ("**Cornish Metals**" or the "**Company**"), a mineral exploration and development company focused on its projects in Cornwall, United Kingdom, announces the exercise of stock options for 325,000 common shares without par value at a price of 20 cents per common share in the share capital of the Company (the "**New Shares**") for consideration of C\$65,000 (£42,500).

It is expected that Admission will become effective and dealings in the New Shares will commence at 8:00am on or around October 18, 2022. The New Shares will also trade on the TSX Venture Exchange.

Following Admission, Cornish Metals' Issued and Outstanding share capital will consist of 531,823,490 shares. The Company does not hold any shares in treasury. Shareholders may use this figure as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company.
