CORNISH METALS ANNOUNCES EXERCISE OF WARRANTS AND ISSUE OF EQUITY

The New Shares will rank pari passu with the existing shares and application has been made for the 350,000 New Shares to be admitted to trading on AIM ("Admission"). Following Admission, Cornish Metals' Issued and Outstanding share capital will consist of 534,270,712 shares. The Company does not hold any shares in treasury. Shareholders may use this figure as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company.
